Description of necessary first aid measures

Precautions for safe handling

Conditions for safe storage, including any incompatibilities : Do not store above the following temperature: 80°C (175°F). Do not store at temperatures exceeding 113°F (45°C). Store in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10).
